Sir/Madam,

This is in continuation to letter No. MCI/34(41)(R-83)/2019-Med./109238 dated 16.07.2020 with regard renewal of permission for admission of 5<sup>th</sup> batch of 150 MBBS students at Maheshwara Medical College & Hospital, Telangana submitted u/s 10A of the IMC Act, 1956 to now dissolved Board of Governors in Supersession of the Medical Council of India. It is brought to your notice that the Central Government has on 24th September 2020 notified fully the NMC Act, 2019. Section 61(2) of the NMC Act, 2019 provides as under:

*"Notwithstanding the repeal of the Indian Medical Council Act, 1956, the educational standards, requirements and other provisions of the Indian Medical Council Act, 1956 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under:"*

2. Accordingly your application was processed u/s 10A of the IMC Act, 1956 and Establishment of New Medical Colleges Regulations, 1999. I am directed to convey the permission of the Medical Assessment and Rating Board of the National Medical Commission for renewal of permission for admission of 5<sup>th</sup> batch of 150 (one hundred and fifty) MBBS students of Maheshwara Medical College & Hospital, Telangana u/s 28 read with section 61(2) of NMC Act, 2019 for the academic year 2020-21.

The permission is subject to:

- (i) The Submission of Affidavit from Managing Trustee/president/ Managing Director /Chancellor of Trust/ Society/ Company/ University towards rectification of deficiencies.
- (ii) Establishment of BSL-II Lab for testing of COVID-19 patient.

3. The next batch of students in the MBBS course shall be admitted only after permission of the Medical Assessment and Rating Board of the National Medical Commission for renewal as per regulations that would be framed under section 26 and 28 of the NMC Act, 2019.
4. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under NMC Act and regulations made there under.
5. Discrepancies, if any, may be immediately brought to the notice of the Medical Assessment & Rating Board and the State Government.

In supersession to this Ministry's letter No. U-12012/07/2016-ME.I dated 08.06.2016 and with reference to your fresh compliance/representation submitted in the light of directive dated 13.06.2016 of the Supreme Court Mandated Oversight Committee (OC), I am directed to say that the OC has approved establishment of New Medical College at Medak Dist. in name & style of **Maheshwara Medical College** by Alleti Shrunitha Educational Society, Hyderabad with an annual intake of **150 MBBS** seats for the academic year 2016-17 subject to submission of the following:

- (i) An affidavit from the Dean/Principal and Chairman of the Trust/Society/University/Company etc. concerned, affirming fulfilment of all deficiencies and statements made in the respective compliance report submitted to MHFW by 22 June 2016.
  - (ii) A bank guarantee in the amount of Rs. 2 crore in favour of MCI, which will be valid for 1 year or until the first renewal assessment, whichever is later. Such bank guarantee will be in addition to the prescribed fee submitted alongwith the application.
2. The OC has also stipulated as follows:-
- (a) OC may direct inspection to verify the compliance submitted by the college and considered by OC, anytime after 30 September 2016.
  - (b) In default of the conditions (i) and (ii) in para 1 above and if the compliances are found incomplete in the inspection to be conducted after 30 September 2016, such college will be debarred from fresh intake of students for 2 years commencing 2017-18.
3. Accordingly a Letter of Permission (LoP) for establishment of New Medical College at Medak Dist. in name & style of **Maheshwara Medical College** by Alleti Shrunitha Educational Society, Hyderabad with an annual intake of 150 MBBS seats for the academic year 2016-17 u/s 10A of IMC Act, 1956 is hereby issued subject to furnishing documents/Bank Guarantee as per para 1 above alongwith another Bank Guarantee of required amount in favour of Medical Council of India, New Delhi valid for five years from a Nationalized/scheduled Bank as per MCI's Regulations 1999 for establishment of new medical college with intake of 150 students in MBBS course within 15 days to this Ministry. In the event of non-submission of the affidavit and Bank Guarantees within the stipulated period, this Letter of Permission shall stand withdrawn.



4. This permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to the verification of the achievement of annual targets as indicated in your scheme and revalidation of performance Bank Guarantee. This process of renewal of permission will continue till such time the establishment of medical college and expansion of hospital facilities are completed and a formal recognition of the Medical College is granted.
5. The next batch of students in MBBS course for the academic session 2017-18 will be admitted in the college only after obtaining permission of Central Government and fulfilling the conditions of OC stipulated in para 2 of this letter.
6. Admissions made in violation of the above conditions will be treated as irregular and action under IMC Act, 1956 & Regulations made thereunder will be initiated.
7. Discrepancies, if any, may be brought to the notice of MCI and Central/State Government.



I am directed to refer to MCI's letter No. MCI-34(41)(R-98)/2017-Med./107366 dated 29.04.2017 on the subject mentioned above and to convey the approval of the Central Government for renewal of permission for admission of 2<sup>nd</sup> Batch of 150 MBBS students for the academic year 2017-18 at Velammal Medical College, Hospital & Research Institute, Madurai under Kaloji Narayana Rao University of Health Sciences, Telangana


